1. <u>Welcome and Apologies</u>

The Chairman formally opened the Parish Council meeting and welcomed everyone. Apologies were received from Cllr. Truelove, who could not attend due to a prior commitment at Swale Borough Council.

3. Minutes of the Previous Meeting

Proposed by Cllr. Spencer and seconded by Cllr. Davison; the Minutes of the meeting held on the 8th April, 2013, were agreed by Members and signed.

4. Matters Arising from the Minutes

- 1. **Response from KCC on re-bunding verges in Hearts Delight Road** Clerk advised that she has now heard from KCC and they will carry out this work and will soft bund to a height of two to three feet to hopefully prevent further damage to the soft verges in the future.
- 2. **PCSO Coverage** Clerk advised that PSCO Matthew Link is still covering Tunstall, but there will be changes in the future and he will advise as soon as he is aware of any permanent decisions.
- Royal Charter of Incorporation Elizabeth I It was agreed it would be nice to commemorate this event by the planting of an aptly named 'Queen Elizabeth Rose' Clerk to obtain prices and report back to June meeting.
- 4. Airport Conference Detailed report circulated by Cllr. Mitchell noted.

5. Finance

- 1. **KALC Annual Subscription 2013/14** Members agreed to renew the subscription at a cost of £330.58p.
- Commemorating Frank Panton A memorial seat was suggested by Members. The Chairman to discuss this with Mrs. Panton and the Clerk to obtain prices for a seat and plaque; this item to be placed on the June Agenda.
- Audit 2013/14 The internal audit report, prepared by David Buckett for the year ended 31st March, 2013 was circulated, noted and accepted by Members

Members approved the Bank Reconciliation, Explanation of Variances and Annual Return, including the Annual Governance Statement, for the year ended 31st March, 2013. Clerk to now submit all documentation to Littlejohn, the External Auditors.

- 4. **Appointment of Internal Auditor -** Clerk advised that the previous Internal Auditor, Mr. Cozens, has now retired. Members approved the appointment of David Buckett; formerly Head of Finance at Swale Borough Council; who now carries out Internal Audits for 25 Parish Councils and finance training for KALC. David is a member of CIPFA.
- 5. **Insurance Cover Renewal 2013/14** Agreed the sum of £327.37p, being the renewal premium due to Zurich Municipal for 2013/14.
- 6. **Precept 2013/14 and V.A.T. Payments** Clerk advised that half the precept £4222.50p; half the lighting grant £95.00p and V.A.T. repayment of £186.22p in respect of 2012/13 have been credited to the Council's current account.
